#### Exemption Policy Specialist

The National Accounting Council (NAC) is the accountancy and auditing regulator, and standard setter for private and public sectors; and the Kampuchea Institute of Certified Public Accountants and Auditors (KICPAA) is the national professional accountancy body in Cambodia, which were established by the Law on Accounting and Auditing of the Kingdom of Cambodia.
